Information for distributors of the Product

This summary document is being provided to you to fulfill our responsibilities under PRIN 2A.4.15R and PRIN 2A.3.12 R (2).

01. SUMMARY OF OUR ASSESSMENT

We have assessed that:

- Our "Real Life" Residential product range continues to meet the needs, characteristics, and objectives of customers in the identified target market.
- The intended distribution strategy remains appropriate for the target market.
- The Product provides fair value to customers in the target market (i.e. the total benefits are proportionate to total costs).

02. PRODUCT CHARACTERISTICS & BENEFITS

The products are designed to meet the needs of the target group looking to finance the purchase or remortgage of their first or subsequent home and/or raise capital. The product features and criteria are designed to support these needs.

- Fixed rates on 2 or 5-year terms
- Options to accommodate LTVs up to 90% (subject to conditions)
- Mortgage Term up to 40 years
- Fee options that can provide a lower Completion Fee, Valuation costs and cashback
- Option to borrow from £25,001 up to £1m (75% LTV), £750,000 (80% LTV), or £600,000 (90% LTV)
- Minimum Ioan size £120,000 for 90% LTV
- 90% LTV only available on purchase transactions for properties with an Energy Performance Certificate (EPC) rating of A-C
- Qualifying credit score required for 90% LTV
- Available on new or existing homes

Large Loan

- Minimum Ioan £500,000
- Maximum loan £1.25m to 75% LTV, £1m to 80% LTV

Interest Only

- Minimum Ioan £500,000
- Maximum Ioan £1.25m to 75% LTV, and Part and Part 85% LTV
- Minimum term 10 years
- Maximum age at end of term 70 years

The Real Life range is designed for customers whose personal circumstances provide additional complexities regarding financial histories or incomes.

RLO provides for income profiles including but not limited to:

- Self-employed trading 12-24 months, 1 year accounts using profit before tax.
- Self-employed trading over 24 months, 2 years accounts using profit before tax.
- Employed (with commissions, bonuses, car allowances, regional and shift allowances).

RLO provides for customers whose credit profile matches the following characteristics:

- 0 unsecured arrears within 36 months
- O secured arrears within 36 months
- No CCJs within 36 months
- No unsecured agreement defaults within 36 months (utility and communications defaults are not considered adverse credit)
- No history of bankruptcy, IVA, repossession, debt management plans
- No Payday loans within 36 months of application.
- Minimum credit score of 450

The Product is not designed for customers who:

- Do not pass our lending or property criteria
- Fail our affordability tests
- Have significant current financial difficulties
- Do not intend to reside in the property
- It has been explained that this proposition is aimed at those who's circumstances, needs and objectives are best met by products available from specialist lender. It is difficult to foresee circumstances where a customer who has received a recommendation for a TML product would also be able to easily access mainstream alternatives.
- The range is not designed to give customers that cannot afford the loan access to finance. There are measures within the product range that help with structuring costs (such as the fee assistance package) but this does not overcome the fundamental long-term affordability assessment that is undertaken on each customer.

04. CUSTOMERS WITH CHARACTERISTICS OF VULNERABILITY

First Time Buyers: the need for extended borrowing may create conduct not aligned to the customer's own best interests. Similarly, FTBs are less likely to have a comprehensive understanding of mortgages or the mortgage market and may require a greater level of engagement in the advice process. We do not expect any of our customers (FTB or subsequent purchasers) to have a comprehensive understanding of mortgages, the mortgage market, or the financing alternatives available to them. They require advice and support to ensure they understand the information being presented to them and the implications of the arrangement they are entering. Receiving good advice is critical to reduce the risk of customer harm.

Remortgaging: We do not expect any of our customers to have a comprehensive understanding of mortgages, the mortgage market, or the financing alternatives available to them – this is despite refinancing an existing mortgage. They require advice and support to ensure they understand the information being presented to them and the implications of the arrangement they are entering. Receiving good advice is critical to reduce the risk of customer harm. There are a broad set of reasons why customers may be accessing equity to raise capital, including debt consolidation. Capital raising may indicate individual circumstances relating to stresses from lower excess income (but equally does not always indicate financial stress). This is highly individual and based upon an assessment of the applicant's position reinforcing the importance of appropriate advice.

The Real Life range is designed for customers whose personal circumstances provide additional complexities regarding financial histories or incomes, which is likely to include some customers with characteristics of vulnerability or who will experience vulnerability over time. Some higher potential of vulnerability compared to mainstream lenders arising from reduced financial resilience indicated by lower credit score/income complexity.

Intermediaries should continue to comply with your obligations to ensure that you treat customers in vulnerable circumstances fairly.

05. OUR ASSESSMENT OF VALUE

We have developed a comprehensive and robust assessment process which evaluates several aspects of our business to determine the value of our mortgage product. This analysis is used to ascertain whether the Product delivers fair value for customers.
